SECTION 2 – HAZARDS IDENTIFICATION

Emergency Overview:

This is a personal care / cosmetic product that is safe for consumers and other users under intended usage. It is non-hazardous.

Potential Health Effects:

Eye

Contact may cause mild, transient irritation. Some redness and / or stinging may occur.

Skin

Not expected to be irritating, sensitizing, photoallergenic or phototoxic when used as intended. This is a tingling and warming lotion. It will provide these sensations as the product is intended.
